	Both of my parents are deceased, even if I am not adopted.	Copy of your parents' death certificate(s) or signed letters from family members documenting your circumstance. (If one parent is deceased and the other parent's whereabouts are unknown, attach a letter of explanation.)
	I am currently, or was a ward/dependent of the court or in foster care since the age of 13.	Copy of court documentation regarding your ward/dependent of the court status.

Official letter from a high school district homeless liaison or the direct of a U.S. Department of Housing and Urban Development funded homeless shelter.
